Provincial Coordinator's Comments

We have reached a time within the construction industry where it is anticipated that approx. 20% of the current labour force are expected to retire over the next 10 years. With that in mind, the province's construction labour force will need to grow substantially to meet the demands of the ever-changing landscape of this province.

The potential influx of workers will mean that more attention will need to be placed on vulnerability at the workplace. We cannot shy away from the fact that workers that are new to the construction industry, whether it be a young worker or new immigrant, lack the skill, knowledge and understanding to work safely.

A recent "Fall from Heights Fatalities Analysis" was created by the Ministry, which was provided to the Section 21 committees, analyzes data from 2009 to 2016. This report breaks down information on many levels including the month of the year or the time of day in which fatalities resulting from falls are most likely to occur. The age group that had the highest number of fatalities was between the ages of 45-54 but what is important to note is that approx. 45% (29 out of 64) of the fatalities occurred with workers who had been in their role for less than one year. If that information doesn't leave you shaking your head then let me provide you this data, out of those 29, 14 occurred within the first month. So here we have workers that are new to their role die after one month, a month which was probably full of excitement because of new employment and new possibilities.

We hear it all the time, whether in sports or finance...numbers don't lie, and those numbers tell us we need to place extra attention to these workers. We need to not only teach them how to be a good tradesperson and show them the "tricks of the trade" but to understand that health and safety is the most important component of their trade. More so than anything else.

It is on us, as an industry, to ensure that these workers are provided with the required training, proper personal protective equipment, supervision and a safe workplace because their hazard recognition will be poor and therefore they will not know what information or equipment to ask for and in some cases be afraid to do so. The future of this province and the future of our construction industry relies on you, me and everyone to protect and nurture these workers.

I want to leave off by saying that our annual *Occupational Health and Safety in Ontario:* 2017-18 Annual Report is now available online.

Ottawa Permanent Roofing Fined \$80,000 for Occupational Health and Safety Violations

Convicted: Ottawa Permanent Roofing Inc.,900 Greenbank Road, Suite 385, Ottawa, Ontario, a company that provided roofing services.

Location: A roofing project located at a residence in Ottawa, Ontario.

Description of Offence: A worker suffered critical injuries when a fire broke out on a rooftop balcony.

Date of Offence: July 5, 2017.

Date of Conviction: November 29, 2018; Sentencing: January 7, 2019.

Penalty Imposed:

 Following an ex parte trial (in which no one appeared in court on behalf of the defendant), the company was fined \$80,000 in Ottawa court by Justice of the Peace Andrew I.
 Seymour; Prosecutor Matthew De Lio, Student-at-law; Crown Counsel Gráinne McGrath.

Background:

- Ottawa Permanent Roofing was hired by a homeowner to supply and install a new roof on a two-storey residential home, including a second-storey balcony. Adhesive glue used in the installation of the balcony membrane caught fire while three workers were present on the balcony.
- Two of the workers caught fire. One received serious burns to the arms, legs and torso as a result.
- There was no fire extinguisher on the balcony.
- There were no written emergency procedures for the project.
- Workers did not have an adequate means of egress from the balcony during an emergency.
- Section 17(1) of the *Regulation for Construction Projects* prescribes that "A constructor shall establish for a project written procedures to be followed in the event of an emergency and shall ensure that the procedures are followed at the project."
- Section 52 of the regulation prescribes that "fire extinguishing equipment shall be provided at readily accessible and adequately marked locations at a project," and "at least one fire extinguisher shall be provided...where flammable liquids or combustible materials are stored, handled or used."
- Section 71 of the regulation prescribes that "adequate means of egress shall be provided from a work area to permit the evacuation of workers during an emergency."
- Ottawa Permanent Roofing failed to ensure that the measures and procedures prescribed by sections 17.1, 52, and 71 of the Regulation for Construction Projects were complied with at the workplace, contrary to section 23(1)(a) of the Occupational Health and Safety Act.
